

## Developments at Catholic Social Services

### Inviting Associate Membership of Catholic Social Services Victoria

Full Members of Catholic Social Services Victoria are Catholic community service works operating in Victoria. These are listed on our [website](#).

Life membership is conferred on an individual by the Council in recognition of individuals who have made an outstanding contribution to the work of Catholic Social Services Victoria and to the wider welfare sector. Sr Tony Matha ibvm AM and Fr Kevin Mogg AM are the current life members.



### CSSV Council planning

Members of the CSSV [Council and its committees](#) met on 2 December to focus on planning for 2012. It was an energised session, facilitated by Sheree Limbrick of CatholicCare.

2011 was seen as a good year for CSSV in its role of contributing to the mission of the Church in service and work for justice through its work as a peak body for the Catholic community sector. Highlights included activity in advocacy around criminal justice reforms and leading submissions and networking across a range of current issues. There was a strong network development and member support program, focused largely around sector gatherings and events, but including the welcoming of five new members and support for the establishment of CatholicCare Victoria Tasmania. Among other contributions to reflection on Catholic identity, a highlight was the conference on Mary MacKillop's contribution to Catholic social services.



The framework of the current strategic priorities was re-affirmed, namely

- Policy & advocacy
- Network development and member support
- Catholic ethos and identity

Building on 2011, we need now to continue to strengthen our contribution to the sector and to those that we serve: to energise the sector as a network, and to involve all age groups; to continue the broadening of ownership within the

CSSV community of the work program. The need to focus and deliver well on a number of agreed priorities was accepted by all.

Any comments or suggestions for our work program would be welcomed, including suggestions on particular activities or topics that might be addressed. This would then be fed into the plan to be considered by Council in early 2012.

### Welcome to Lucia Brick

Welcome to Lucia, who has recently joined Catholic Social Services Victoria as Executive Assistant in our office, joining Denis Fitzgerald and Terry O'Shannassy. Lucia comes to CSSV after a temporary role at Carers Victoria, eight years with Macedon Ranges Council, and earlier work with the Kyneton Parish and with the Religious Education Texts Project of the Melbourne Archdiocese. Lucia has made a great start, and is looking forward to being of assistance to all of our members and stakeholders, and to meeting you all over time.

Thanks to Carmen Montalto who helped out in the office over the past five months, and enabled us to implement our full events calendar over that period.

### Australian Catholic Religious Against Trafficking Humans - ACRATH

ACRATH has been gaining in momentum as it works on a number of fronts to address trafficking issues in Australia and beyond, and to assist the people, largely women, who are the victims of this trade.

One constraint to their work has been the shortage of housing options, both crisis and longer-term. This is notwithstanding an increasing level of interest from Governments.

A group of CSSV members that work with women who have been homeless recently met with ACRATH, Red Cross and others to explore options for women who have been rescued. While solutions are constrained by current shortages of accommodation, the meeting usefully clarified some of the needs and issues, and a further meeting on 8 February 2012 will explore more detailed housing options with member providers. ### **Vulnerable children**

The wide-ranging Protecting Victoria's Vulnerable Children Inquiry is drawing to a close, with a report due to be tabled in Parliament on 8 February 2012. A recent gathering of CSSV members active in this field shared ideas around the likely impact of recommendations coming from the inquiry, and what might be an appropriate response on release of the report.


One key issue will be the availability of adequate funds to provide the level of care that is needed. But there are also many others. This will be an important focus in the new year.

### **Criminal Justice – focusing on a safer, more just society**

The Victorian Government's active agenda in criminal justice has continued in the news, as various reports and forums highlighted alternatives to the 'tough on crime' policy proposals that are working through the system.

With members and with the Inter-Church Criminal Justice Task Force, CSSV is submitting a range of budget proposals that would ameliorate aspects of the current system, particularly in relation to diversion to restorative processes at the time of trial, and to support in prison and beyond. We are also finalizing a paper calling for a focus on the longer term costs of increased utilization of prison, compared to measures to prevent the development of criminal behaviour, or to intervene early to assist those, especially young people, who need help.

This complements the work of Smart Justice, of which we are part, and the strong advocacy of Jesuit Social Services, CatholicCare and other member organisations.



### **Ministry to Priests**

CSSV has been working with the Ministry to Priests to provide an introduction to community services to a number of priests who have moved to Australia to work in the Archdiocese of Melbourne. Thanks to Sacred Heart Mission for augmenting this with a hands on visit to their site on 13 December.

This is one element of our longer-term program to optimize the connection and the sense of shared mission between Catholic social service providers and the Parishes that operate throughout Victoria.

### **Mental Health workshops**

Work is underway to develop a short series of follow-ups to the mental health workshop held in September 2010. These are intended to assist member organisations in their own services as they interact with people with mental illness. [Helen Burt](#) is working on this, with members of the Member Support Committee. Any ideas or comments would be most welcome.

### **CSSV Mission Network**

This network supports people within an organisation that have responsibility for, or a particular interest in, the strengthening of the mission-focus, and its integration into the life of the organisation. The network held its final meeting for the year on 17 November, with a discussion that focused in part on the role of boards in articulating and driving the mission of an organisation. Induction and formation for Board members and a number of related issues provided lots of food for thought. Thanks to those from a range of members, and from Catholic health service providers, who participated during the year.

The network will meet every two months in 2012. [Denis Fitzgerald](#) would be happy to provide further information, etc, or to discuss participation in the network.

### **Media items - CatholicCare**

Several recent items in *The Age* have been critical of Catholic social service providers, and in each case the organisation concerned needed to provide further information to clarify the reports and put them into a context that would enable the reader to understand the situation.



CatholicCare Melbourne [responded](#) to criticisms published in *The Saturday Age* on 3 December of the way the Catholic Church and CatholicCare manages sexual abuse claims.

CatholicCare Sydney [responded](#) to allegations of misconduct in employment service program that were aired in a front page article in *The Age* on 12 December. CatholicCare Melbourne also needed to clarify for readers that this article in fact referred to the Sydney organisation, and not to Melbourne.

CSSV supports both organisations as they work through these matters; and we reflect that these issues, and the reporting of them, can be an opportunity for all of us to strengthen our resolve to excel in our mission-driven commitment to the people that we serve. These consultations provide an opportunity to input in Government thinking, and to work with representatives of other religious communities on matters of common interest. A recent positive development, for example, was an offer by ASIO to attend meetings in particular communities to allay misunderstandings about how ASIO conducts its business.
